[1] "Photograph(s)" means all photographic material furnished by Christian J Stanley, whether it transparencies, negatives, prints, digital images or otherwise.

[2] Photographer reserves the time and date agreed upon and will not make other reservations for that time and date. For this reason all payments are not refundable-even if the wedding is cancelled with an exception for (10) below. No other Professional photographer will be permitted to photograph, pose, direct or interrupt while Photographer is working. Any breach of this agreement will constitute a reason for non-completion of the job with no liability to the photographer and the loss of all payments made under this contract.

[3] In return for payment by the Bride/Groom of the full package price, the services to be provided by the Photographer under this contract are: 1. Christian Stanley will be the lead photographer and will provide wedding photography services on the day of the wedding, for a maximum of 10 hours, with Photographer to be allowed all reasonable rest and food breaks. Meals will be provided by bride/groom.

[2]. CJS photography makes no guarantee to capture any specific image or scene and makes no guarantee as to any specific quantity or scene of images, but rather a general and thorough record of the wedding day. The Photographer shall use his best efforts to photograph basic elements of the wedding ceremony, reception and group photos. 3. Bride/Groom will get full resolution images on data DVD disks with "Home use Rights"

Delivery of the data DVD's shall occur within (90) calendar days of the wedding date, and delivery of completed albums shall occur no later than (120) calendar days after the bride and/or groom approve the final album layout.

Should CJS photography deliver after these deadlines, they shall refund a reasonable, mutually agreed portion of payments received. Unpaid bills will nullify the above mentioned delivery deadlines and all materials will be held until final payment is received. If significant portions of the wedding images are lost, then a refund will directly reflect the portion of time of the entire day that was lost.

[4] Home use Rights: This contract includes "Home Use Rights" which means that you can use the images for personal, non-transferable and non-commercial uses. You may make as many prints as you like for yourself, or to give away as gifts. You may place low resolution (72dpi) copies of the images on your personal website for viewing as long as prints are not offered for sale. You may copy the disc to facilitate storing a backup in a separate location. You are personally liable for communicating the limitations of this contract to any person who receives a disc copy, and you are personally liable for any illegal uses that arise from the distribution of these images to other persons. You may not sell the image files or prints produced from the files whether in original form, or after any amount of alteration. Other persons may not use the image files as a basis for the creation of any artworks if that artwork is to be used for any commercial purpose. No rights to these images may be transferred to any other person or company, whether for profit, or as a gift. Client may not assign or transfer this agreement or any rights granted hereunder. This agreement binds and insures to the benefit of Photographer, Client, and Clients principals, is jointly and severally liable for the performance of all payments and other obligations. This agreement incorporates by reference Article 2 of the Uniform Commercial Code and the Copyright Act of 1976, as amended. Client will indemnify and defend Photographer against all claims, liability, damages, costs, and expenses, arising out of any use of any photographs for which no release was furnished by photographer, If you have a question about any specific usage, please contact the photographer to ask for clarification or permission before proceeding with such use.

[5] Unless negotiated in a separate instrument (in writing) all proofs, sample prints, negatives and images remain the property of Photographer and may be used as advertising, display, or any purpose thought proper by Photographer without compensation.

[6] The contracting parties agree that in the event it is necessary to retain the services of an attorney for the collection and enforcement of this agreement, the offending party agrees to pay the other party's actual costs for attorney's fees and other expenses incurred in the collection and enforcement of this agreement. Venue of any legal action will be in Portland, Oregon USA.

[7] Payment of 1/3 the original photography package fee is required to book the date with the other 2/3 paid not later than one month before the wedding date. Fees are non-returnable. No photography will take place and no rights are granted until timely payment is made in full.

[8] In the event of the photographer suffering from any illness, every effort will be made to secure the services of a qualified professional photographer to cover the event. If Photographer cannot perform this Agreement in whole or in part due to a illness, injury, fire, casualty, acts of God or other cause beyond the control of the parties then Photographer will return all fees to the Client(s) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of Photographer.

[9] In the event the Client cancels CJS photography to provide photography services while under contract, all and full payments for prior requested photography services are nonrefundable.

[10] Client has the right to a three (3) day grace period to exit this contract. I must be notified in writing. The postmark shall not be older than three (3) days of the date following the signature of the contracting party. Photographer is not responsible for lost or undelivered mail.

[11] This contract is not valid until it is filled out, submitted and a retainer or full payment has been made. By completing the following information it is understood that you have read and agree to the terms of this contract.

[13] Photographer reserves the right to edit and will be the final authority on the images that will be offered for sale.
